The Convener read out the minutes of the previous meeting dated 15/03/2017 and it was approved by all the members.


**Resolution No.2**

It was decided by the members that the Student Redressal Committee would take care of the Redressal of genuine complaints of students for entire session and they would be forwarded to concern cell/committee.



**Action taken:** Arrange One day college trip and visited to two science laboratory are NEERI, Nagpur and Regional Forensic Science Laboratory, Nagpur.


2. Demand for arrangement of fans in B.Sc.-III classroom.
